# INTERDISCIPLINARY PROJECT WITH UGC ON PROPHETIC MEDICINE

#### **Abstract**

This article aims to discuss about scientific and practical level that analyzes comprehensive new studies and interdisciplinary research possibilities. Prophetic Medicine is a relevant medical system which has been evaluated by researchers as a study of scientific and classical methods in the modern world and invited proposals by Ministries and Universities. Nowadays the society have a concept on Prophetic Medicine which has only surrounded whether in religious or belief methods which has no scientific basis of studies.

But, literally this system which has existed longer than any other branch of medicine in academic history but has been kept away from academic circumstances for some political reasons for that last 500 years.

Now, Prophetic Medicine being recalled for the past quarter of a century with Doctoral works etc. has been designed as a new degree in India under the proposed status of the Central AYUSH Ministry. Currently, the practical sections of academics of Prophetic Medicine underway in Kerala, India. This system has received approval guidance from AYUSH, Central Govt. of India and is being academically re-established at the global level. Based on the seven criteria suggested by them (No. U11018/02/2022-HR(ASM)/E-8149864), the proposal of Prophetic Medicine has been submitted. The previous submission works associated with the Health Ministry consequently, Prophetic Medicine has specifically indicated as *The Prophetic System of Medicine* by the Ministry of AYUSH. Presently, the academic work of Prophetic System of Medicine is underway to devising it for inclusion in the UGC sector as an interdisciplinary study topic.

## Introduction

The ultimate goal of Modern scientific development should be to faster in greater diversity and fundamental breadth in research studies. The primary objective of today's research and educational advancements is to enable focused academic activities in novel scientific inquiries and practical applications. If we travelled through a detailed examination on Islamic academic policies reveals a strong emphasis on promoting new research studies and disseminating global knowledge, leading to numerous progressive achievements.

Medical studies are the foundation of this kind of knowledge. The Golden age, which was a greatest era provides a clear understanding of Islamic wisdom through its studies. However, the distinctive theoretical and practical applications of Prophetic Medicine commonly referred to as Islamic Medicine which require further expansions in today's academic landscape.

Prophetic Medicine offers a more comprehensive and complete approach to medical research studies which more than Modern Medical science. The primary reason for this is that Prophetic Medicine is a field that's uniquely receptive to research and exploration more than any other branch of medicine. For the first time in the world the idea of a University was put forward from Islamic scholars. Notably, the ground breaking achievement was made by a Muslim women. The reason behind it that the important of categorizing the authentic texts of Prophetic Medicine for ease of study and paving the way for further researches.

The breadth of knowledge that exists within each branch of 14 unique branches of advanced science is immeasurable. Therefore, the necessary academic foundations need to be set up in a unique way to bring this unique branches of knowledge to future scientific research.

The relevant systemic approach of Prophetic Medicine should have in the vast structure. Continues educational programs of Prophetic Medicine is on the better possible way. The primary focus of current education policies in India is the University Grants Commission (UGC), an authoritative body. The objective is to academically expand by incorporating Prophetic Medicine into the framework of UGC and introducing degree and postgraduate programs in innovative scientific disciplines. To achieve this, discussions are underway to develop more graduate syllabi related to Prophetic Medicine and explore further activities through platforms like University development.

## ACADEMIC PROGRESSION OF PROPHETIC MEDICINE

Current and emerging educational movements in each country play a pivotal role in maintaining the scientific base of those countries. The field of scientific education has no small role to play in making India a scientifically advanced country. New and diverse research and study projects are need to come forward for that.

In order to bring such a new science to the world, the doctoral project of prophetic medicine needs to be brought to a large scale academically. The aim is to bring it as a deemed University recognized by UGC and to include curricula, research projects in different scientific disciplines. Activities related to this are going on in Kerala. Many project submissions, debates and seminars have been held in various universities and academic centers and all of them have received university-level appreciation papers. At present, there are institutions working in Kerala, India, which are advancing prophetic medicine academically with a scientific background. Faculties were being worked in this field they have degree and PG in Modern medical syllabus also greatest scientists are also followed this system as academically. Also, some of them have a degree in Prophetic Medicine and PhD also.

It has been 24 years since the academic education of this branch of medicine began to spread. The fact is that it is possible to build a new and original scientific foundation for the world through Prophetic Medicine and give importance to proper scientific observations through such an academic restructuring.

The institutions of Prophetic Medicine in India currently functioning under Article 30(1) of the Indian Constitution, which encompasses both classical and scientific curricula. These programs continue to admit new batches, and additionally, treatment programs, health camps, and academic initiatives are also noteworthy aspects of these institutions.

## HISTORY OF INSTITUTE OF ISLAMIC MEDICAL SCIENCE (IIMS) CUM INTERNATIONAL ISLAMIC UNIVERSITY OF PROPHETIC MEDICINE (IIUPM).

In modern world, the come back and academic activeness of Prophetic Medicine are more important. In this new communalization scenario, it will be much helpful to realize the academic importance of Prophetic Medicine.

#### 2000

Founding of institute for Prophetic Medicine. An outstanding doctoral thesis on Islamic Mindology was presented in Psychology department of Calicut University. It was observed and given impression letter by Dr. John Baby.

A 5 year project of five major ailments were successfully done. Such are;

- Heart disease.
- 2. Cancer.
- 3. Leucorrhea.
- 4. Diabetes.
- 5. AIDS.

Under this five year project patients who were afflicted with these diseases received treatment and were cured through the unique way of Prophetic Medicine treatment, observation appropriate interventions.

### 2001

Islamic Mindological treatment studies were organized, associated with Degree Course of Madras University. The program was handed over to some other institutes in 2008.

#### 2002

Synopsis on health science of Prophetic Medicine was prepared in Arabic department of Calicut University. This was later presented in Mallihabad Unani Medical College, which Calicut University recognized as minor research project. It was the same year that application for affiliation of Prophetic Medicine was submitted in Kerala secretariat level and received encouraging reply.

#### 2003

Institute of Islamic psychology and philosophy, was founded on the basis of thesis that submitted to more than 10 masters in psychology department of Madras University. www.liponline.org was founded. "School of seven minds is the doctoral thesis base of this Institute later Dr. Shafi Abdullah Zuhoori who is the founder, academic promoter, proposer etc. of Prophetic Medicine moreover, a medical doctor, scientist was prepared 7 doctoral theses on this topic.

#### 2004

The above mentioned cyber institute became a reason for conduct of debates on seven mind theory of Islamic Mindology even in Captown University, Many academic psychologists gave appreciation letters on this topic. Dr. Shafi Abdullah Zuhoori provide 7 books in seven minds theory.

#### 2005

Began to attempt for academic Prophetic Medicine in Aligarh Muslim University. Debates were conducted in this regard in Ajmal khan Twibbiyya College.

Succeeded in establishing in that medical philosophy of Prophetic Medicine is different from that of Unani. As was instructed to start Diploma course based on this topic, DIMS was started for science students.

### 2006

Some comparative Science debates were conducted in Kottakkal Ayurveda Medical College, Criticism on Ayurveda and idea of cooperative Medical Mission, were presented by Dr. Shafi Abdullah Zuhoori. In academic debates of Govt. Ayurveda College, He has honored by college by giving lecturing expert certificate. Application for affiliation, renewed mentioning this was submitted in secretariat.

## 2007

A debate was conducted with first grade scientists in liver pool University, King Abdul Aziz University like centers. Govt. entrance for academic discourse on Prophetic theory of "Reverse Evolutionary Biology" later, these Universities were responded in debate of this theory.

## 2008

Aligarh Muslim University gave a supportive letter. This was given after checking and approving the essays on starting the medical philosophy of Prophetic Medicine different from the Unani, there we got instruction for starting next batch of DIMS. Practical batch (2<sup>nd</sup> batch of DIMS) had formed. Submission was done on the treatmental effect of Prophetic Medicine especially for fatal diseases.

Visited Malaysian Universities, discussions were done on academic Prophetic Medicine, won appreciation of many authorities. There has been continued two years of debate. Recently, International Islamic University of Malaysia (IIUM) has included Prophetic Medicine in MBBS syllabus.

#### 2009

Academic instructions were made in Osmania, Annamalai Universities. New medical projects were submitted in Wilfred University. Received appreciation letter as a result of debate conducted, In Malabar more than ten aided educational institutions gave promoting letters.

#### 2010

Project submitted by IIMS student, anchor of photo cardiology in Aligarh Muslim University. Received promotional letter. Also received D-lit suggestion for the same. Discourse conducted in department of pharmacology in A.M.U found high success. Received promoting letter. Received instruction for student group submitting pharmacology, lab practical of Prophetic Medicine (DIMS, 3rd batch).

Two year discourses in Malaysian University found result. Prophetic Medicine was approved as a special particular paper in medical syllabus of Kaulalampur University.

Dr. Shafi Abdulla Zuhuri has declared a complete charity mission with Prophetic Medicine at 10<sup>th</sup> anniversary of his institute. Around 50 lakhs of rupees have spent to this mission for dreaded patients.

## 2011

Kerala Govt. Arogya Bhavan invited submission in Prophetic Medicine. This was result of application submitted in secretariat. Dr. Shafi Abdulla Zuhuri was replied by explaining pathology, pharmacology and pharmacy system of Prophetic Medicine.

#### 2012

A project on Photopharmacology of Prophetic Medicine was presented in pharmacology department of Calicut Medical College. The basic topics of Prophetic Medicine such as Pathology, Photobiophysiology etc. were described.

The project presented as" this is a science which helping for Modern Medicine also" was well received, recommended for bringing up the system as separate faculty in University. Got affiliation or Bharat Sevak Samaj vocational education by central Govt. of India.

#### 2013

Detailed academic discourse on Universality of Prophetopathy was organized enthusiastically. Discourses were held on camel medicines of Prophetic Medicine in veterinary University, comparative medicinal Philosophy in Pariyaram, K.M.C.T. and Kottakkal Ayurveda Medical College etc. As a result of debates and discourse conducted in medical college, Universities, science institutes etc. received promoting and recommendation letter for Prophetopathic faculty from Aligarh Muslim University. It states that for the establishment of faculty and college of Prophetopathy and bring it under the central Govt. fund for Alternative departments. Educational Board of Prophetopathy was registered with Kerala Govt. under the board. A 10 membered Academic bench was formed.

#### 2014

Kerala Govt. Arogya bhavan instructed for attempts for affiliation under Kerala Health University. Syllabus of degree course on Prophetic Medicine, formulated under Prophetopathic Educational Board that submitted in Kerala Health University, Started BPMS doctoral course, Scientists from International institutions like international University of Complementary Medicine, King Abdul Aziz University visited BPMS classes and gave guidance for affiliation, Submitted doctoral research project on 'Umaqazi's Prophetic Medicine.

## 2015

## DOCTORALISM by PROPHETOPATHY LEARNING

#### 2016

In 2010 three academies for Ulama Twibby activities were established which later evolved into a Twibby Open University Committee in this year. This has come into an Open University which has named Thwibbunnabavi Open University (TNOU).

Established as per 1962 World Health Organization Alma Ata Declaration and accorded international recognition to make Alternative Medicine popular and based on the record of deeds dated September, 1962 located at the Public Registry of Deeds of the Kazakhstan Socialist Soviet Republic No 115620 – 20-6-30. Constituted under the authority of MEDICINA ALTERNATIVA-ALMA ATA 1962). Incorporated for Education, Practice, Research, Development, Propagation and Promotion of Prophetic Medicine.

#### 2017

Constitutional University for Prophetic Medicine and other associated subjects were formulated based on Indian Constitution and its fundamental book was published thereby. Based on it Open University and Regular University concepts were formed and a legislative Council with Academic and Legal Council was also formed.

#### 2018

For International Islamic University of Prophetic Medicine the Jamiathu Twibbunnabawi Trust (JTNT) was registered. A board of Trustees consisting of scientists and doctors were formed under it. Statute was published in Kozhikode science planetarium ground. Prophetic Medicine Mega Degree and other fifteen courses proposal was prepared.

## 2019

Constitutional University Grading (CUG) based valuation system was made and for this purpose a Trust for Constitutional University was also made. Based on it the Open International University of Alternative Medicine was regarded and reestablished. Its courses were reformed based on Prophetic Medicine and the Academic Council, board of Studies etc. were regarded based on board of Studies as per Article 30 (1). Then in the basis of Constitutional University an Oriental University of Allied Methods was formed in association with 12 countries. For this a Governing body with national and international experts were set up and a campus was registered in Ramanathapuram for this University.

#### 2020

Covid Cure through Prophetic Medicine through this project Prophetic Medicine got an entry to AYUSH Ministry of Central Government. A lab research work of rupees 1 Crore was initiated for the Corona Cure project and its works were done around the globe. Various Scientists, science students, religious scholars etc. took part in the project and later on based on it PhD research works based on it for virology, Photo immunology, lacto immunology etc. were initiated thereafter. In countries like Saudi Arabia, Pakistan they took special initiatives for the project. For International Islamic University of Prophetic Medicine, its preface building was completed and its course works of BSc Mindology began. More than 40 PhD's related to Classical Prophetic Medicine was done and for this purpose a guidance body was made and moreover 50 plus Scientific PhD works were also done regarding Scientific Prophetic Medicine. In AYUSH Ministry Prophetic Medicine related textual documents were published and as per Health Ministries instructions Degree proposal for AYUSH was prepared.

## 2021

IIUPM got an International peace award for the establishment of constitutional University and Proposal of 15 degree projects. More than four Academic seminars were done with the subjects of Photobiology, Cardiac Intelligence in CUG level Universities.

## 2022

1. The year 2022 is the year of milestone of biological fulfilment of modern Prophetic Medicine courses. This is because photobiology, which was previously a philosophical concept, has been transformed into a biological study with a complete syllabus. This subject was presented and

discussed by a gathering of international biologists at Kasargod Central University in Kerala and its certification was also obtained.

Furthermore, a curriculum was developed for the subject of Photobiology of Prophetic Medicine, and resources were made available for discussion on topics such as medicine, biology, physiology, and other related fields.

2. 70 research thesis were conducted based on classical Prophetic Medicine, and comprehensive guidance was provided to Ph.D. scholars and also provided all academic support to achieve those Ph D

Based on these 70 research topics, a dedicated research reference library was established at Kozhikode South Beach, providing a valuable resource for future research studies on Prophetic Medicine.

- 3. We were completed the homework of 40 doctoral theses as science based subjects after the presentation of Photobiology submission.
- 4. We have completed the home work of research studies on the subjects of such as Zoology, Botany Pharmacology, Biochemistry, Biotechnology and Phyto-chemistry for PhD those who are Post graduated in these subjects. Now the academic resources that are ready to give as full guidance to such scholars and these are also at the forefront of our academic activities.
- a. The Educational Board was duly registered and became as official.
- b. The Finance Committee has formed with who are well expert in finance management at the level of Financial Planning Committee for this institution.
- c. The Senate and Senate Hall were established as part of the establishment of the University. Also the Senate Constitution was promulgated to the members of the Senate and the Senate trainings were held accordingly.
- d. In the first phase of deciding 15 degrees, there was a board of studies, syllabus and books required for a trial degree and on that basis the trial degree was brought to a regular degree.
- e. Properly trained the faculties for BSc. Mindology (Islamic Psychology) degree.
- f. As per the course of BSc Mindology, proper training was organized in schools by scholars who were taken the Ph.D. in Islamic Psychology/ Mindology.
- 5. We have published the first part of the direct submission of the Ministry of AYUSH department and later the two parts were submitted via online and offline as per their instructions which was published with in two volumes as around 500-pages has published as book at the level of university reference libraries.

## 2023

The most significant event of this year that Islamic Universities are being to aim for establishment on the basis of CUG with UGC accreditation and three textbooks based on the Thwibbunnabavi concepts for University establishment have been published both in Arabic and English languages. Behind this noteworthy feats over the past 23 years all the ground work has been completed to organize Diploma, Degree, pg., PhD and Post-doctoral degree programs in Prophetic Medicine and it was submitted. Consequently, a comprehensive bylaw has been formed on that basis and published in this year.

Rather than developing many new formulas of cellular medicines that are similar to other medical branches but differ in theory, the highlight of this year is that all the foundational aspects of BpT Remedies, which is the basic medicine of Prophetic Medicine the laboratory works and basics of them have been documented as properly.

A lab work that was based on a solid foundation, apart from homework, has been completed, and all extraction models have been presented as trial medicines. Moreover, as part of Prophetic Medicine, a patent Pharmaceutical company was established under the name TNR, and the necessary documents for manufacturing medicines with a license were fully prepared and finalized.

## **CONSTITUTIONAL UNIVERSITY GRADING (CUG)**

CUG is established for the aim to build a religious cultural health system which is promised to accomplish the religious or classical studies. In this includes Islam, Buddhism, Christianity, Ambedkerism etc.

It is the act of studying the Eastern or Oriental Philosophy. According to article 30 (1) Islamic Universities can be established by Ulama community as Religious Minority. Along with that, the integrated form of Islam and Ambedkarism (liberated vision of Buddhism) should be developed in the Muslim minority based University. Because Islam, Buddhism etc. are included in category of Minorities. These Minorities themselves have their own Philosophy, Science, Schooling, graduation etc. Autonomous Universities can be established for these Minorities according to Article 30 (1) of the Constitution of India.

Organisation of Islamic Universities and Allied Madrassas are CUG'S referred society is the best example of this.

Currently, two Universities are functioning based on this constitutional University Grading.

## 1. OPEN INTERNATIONAL UNIVERSITY OF ALTERNATIVE MEDICINE

This University is the best example of CUG system of medicine. The first deed registered in terms of constitutional University Grading (CUG) for the Open Islamic University of Allied Medicine among Prophetic Medicine Universities. This OIUAM is established in 2008.

This University is working under the society of Organization of Islamic University and Allied Madrassas (OIUAM) which was registered under Article 30(1) of the Constitution of India with the objectives of re-vitalizing Islamic Sciences by establishing an autonomous University. This is the self-property and building in Thenkashi district, Courtallam in Tamilnad. In this the Ulama community has the right to set up Universities which gives autonomous degrees for Prophetic subjects.

Degree and PG courses are organized under this and had given courses to medically qualified doctors. In a hope of including the degree courses formed by this Open University in UGC's University syllabus. Our team submitted this to Kerala Health University. No further decisions have come from them even after four years now. In this situation we approached the Hon'ble Kerala high court and the high court examined the formation of this Open University based on CUG and approved this and instructed Kerala Health University to make these courses in a much more elaborated manner.

Based on this the Ulama community of around 100 scholars registered a society in Government of Tamil Nadu based on the article 30(1) and under this the Open University is being formed. Prophetic Medicine was included in the Alternative Medicine list on the year 2017 by the Ministry of Health and Family Welfare of central Government of India (F.No. 1.11012/4/2017 letter) Based on this a statement was added to the registered bylaw of the Academic Council lawfully. Since this bylaw is a registered and published one the University naturally obtains the right to conduct degrees and other Academic programs of various Alternative Medicine streams.

## 2. OPEN INTERNATIONAL UNIVERSITY OF ALLIED MEDICINE (OIUAM) - PAYAMBRA.

This Open University is different from formerly one which were given and complete the Degree, PG and PhD courses as a scientific base of study with a distant authenticated.

The basis of these two Universities is a religious basis. Now, the aim is to convert all of these to include scientific aspects-based courses as interdisciplinary method along with UGC.

The project and syllabus for Prophetic Medicine Alternative University won national innovative educational research award and post-Doctoral certification on the Dr. Shafi Abdullah Zuhoori as the ideologist of Prophetic Medicine Universities.

## **VISION & MISSION**

## **UGC Intervention with CUG**

As mentioned above, various Prophetic Medical courses are being conducted in different institutions based on CUG, while, Jamiathu Twibbunnabavi Trust received a notice F. No. 6-1/2022 (AMPC) from UGC. The notice stated that operating under the name of a University is not allowed unless it is under the UGC, and that any other institution would be considered fake and would be published as such.

Discussions related to this matter were held in the CUG sector. Many senior academicians, including those who had retired from UGC, participated in this conference. Meanwhile, the UGC published a notice on its website stating that operating under the name of a University without its approval is illegal. In such a situation, JTNT approached the Kerala High Court, arguing that CUG has constitutional right and legal validity. The High Court recognized this system as a cultural and health system acknowledged its constitutional rights and granted permission to conduct degree courses and the court also suggested there should be a clear understanding with UGC.

For such an understanding the court directed a UGC-CUG conference (Judgment, WP(c) No.18188of 2022). Accordingly, such a conference was held and debates were held on the authority to independently establish and conduct Islamic science subjects as Universities. However, it has been decided that since Prophetic Medicine is a medical subject, it is not limited to a religious and cultural field, but as a science, it should be conducted as an authorized course of UGC. JTNT came to the decision that instead of arguing in court etc. it would help to remove misunderstanding in society. This is how the decision of CUG University with UGC accreditation was decided. That one resolution was taken authoritatively by JTNT and sent its authoritative messages about the feasibility of Prophetic Medicine courses in UGC as an interdisciplinary subject.

## INTERNATIONAL ISLAMIC UNIVERSITY OF PROPHETIC MEDICINE (IIUPM)

International Islamic University of Prophetic Medicine is established to make Prophetic Medicine science active in global level through Degree, PG and PhD. This autonomous University is working according to the Article 30(1) of the constitution of India, also as per the judgment of Kerala high court (18188/2022) and as per the reply given to the UGC.

Prophetic Medicine can be modernized only by recovering its nearly 10 science branches. Since this system isn't taught in any kind of degree, PG and PhD level in any part of the world. In present scenario, the UGC affiliated University research situation are to be utilized and these are to be submitted in Doctorate level. IIUPM is aiming to conduct UG/PG courses using this PhD holders.

Later, it aims to transform in to a Deemed University under the UGC model and facilitate numerous academic programs and authoritative studies. For that many degree proposals have been issued for this curriculum and planned to be brought under the International Islamic University of Prophetic Medicine (IIUPM) which as a deemed University.

## 15 courses were planned to bring in to a curriculum base.

- 2. BSc Photobiology.
- 3. BSc Cosmology.
- 4. BSc Creational biology.
- 5. BSc Humo-biology.
- 6. BSc Healthy Engineering.
- 7. BSc Photo Phytology.
- 8. BSc Nursing in Prophetic Medicine.
- 9. BSc in Prophetic Medicine Pharmacy.
- 10. BSc in Technical Prophetic Medicine.
- 11. BSc in Prophetic Medicine Herbarium.
- 12. BA in Medical Sociology of Prophetic Medicine.
- 13. BA in Prophetic Medicine Hospital Management.
- 14. BA in Pedagogy of Prophetic Medicine.
- 15. BPMS: Bachelor of Prophetic Medicine and Bachelor of Surgery.

## **Medicinal Doctoralism**

Since it is a course based on medical doctoralism, the first preference should be given to the doctoral course of Prophetopathy. Study duration will be 5 years. Leading to B.P.M.S (Bachelor of Prophetic

Medicine and Bachelor of Surgery) Degree in Prophetic Medicine had to be imbibed with any of the UGC recognized degrees Botany, Zoology, Psychology, Medical Sociology, Medical Physiology etc. These courses have been formulated in a way that it should be more scientifically and technically symphonize to human nature.

#### Conclusion

In this era where new research studies and their possibilities are highly sought after, a medical science based solely on research should be academically discussed. The field of 'Islamic Medicine', also known as 'Prophetic Medicine', which is the foundation of doctoral research, should be maintained at a high academic level. Just because it is mentioned under a religious name, it should not be limited to religious beliefs and minor health advice. Rather, it should be a field with a strong educational foundation, surpassing other medical research fields. Therefore, this medical field should progress to a university level with a scientific foundation, beyond a religious platform. The authorities behind this are making great efforts to present Prophetic Medicine as a UGC-interdisciplinary field, moving away from being a religious minority constitution. This medical field, with its authentic and correct scientific credentials, will be a significant contribution to future study and research progress.
